Trade shortage will be exacerbated by a need to 'power up' skills: Report.

Canada is expected to see a shortage of at least 10,000 workers recognized Red Seals trades over the coming five years. In this, 25 per cent of Canada's 4 million trades workers will need to upgrade their skills within the same time frame as there is significant demand for digital and soft skills. The report is called "Powering Up: Preparing Canada's skilled trades for a post-pandemic economy" which states that employers and policymakers must address the widening digital skills gap and tech advances in the workplace.

- stimulate job creation and economic growth by producing Ontario-made goods
- drive innovation and emerging technologies
- connect small businesses and entrepreneurs to the government and its customers
- deliver greater value for taxpayer dollars

In the context of COVID-19, the new agency will also ensure we will always have what we need to keep our province safe and secure by making it easier to source personal protective equipment (PPE) and other critical supplies and equipment (CSE) across multiple organizations.
